- 1. This form must be completed in black ink by the organisation applying for membership.
- 2. This form must be submitted for application or renewal 30 days before the Annual General Meeting.
- 3. All community based organisations or businesses operating in the George Police area can apply for membership.
- **4.** All organisations applying for membership must attach a signed copy of a Letter of Accredication, on the organisation's letterhead properly mandated, indicating the following:
 - 4.1 Management and other officials.
 - 4.2 Aims and objectives of the entity/organisation.
 - **4.3** Two (2) copies of the identity document of the person mandated to represent the organisation to vote or Sole Proprietor.
 - **4.4** Two (2) copies of the identity document of the person mandated to represent the organisation to observe the proceedings NOT applicable to Sole Proprietors.
 - **4.5** Please note that the person mandated to vote and the person mandated to observe this proceedings cannot be the same person. Unless it is a sole proprietor where he/she can only be mandated to vote.
- 5. It must be noted that the persons mandated to represent the organisation or business will be subjected to a screening process if there is any suspicion that the person(s) mandated to represent the organisation/business, or the organisation/business itself or it's managerial staff, are involved in serious crime and/or has a suspected criminal record.
- **6.** All communication will be through email.
- 7. Sole Proprietors need only to complete Particulars of the Organisation/Business or Sole Proprietor.
